


Knowledge Sharing Agreement (MOU)

- Will sponsor the team LDCE for SAE BAJA or equivalent national/International event.


BREACH OF AGREEMENT

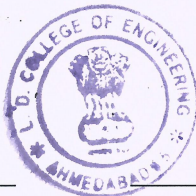
