- Any projects that shall be conducted are of mutual interest and benefit to both parties hereto.

#### **GENERAL AREAS OF COOPERATION AND COLLABRATION**

1.1 Sid Consultants, Ahmedabad and L. D. College of Engineering, Ahmedabad agree that cooperation shall be carried out through academic, training, and research associations

relating to, but not limited to providing domain-specific platform for civil engineering students for site visits for practical know-how.

- (i) Exchanging faculty and industry-experts as per identified academic and industrial requirements.
- (ii) Providing techno-managerial support to students on their industrial projects, as a part of curriculum.
- (iii) Preference for student of L. D. College of Engineering, Ahmedabad for placements at various opening in the industry.
- (iv) Training for faculty of L. D. College of Engineering, Ahmedabad, for latest technological advancements at Sid Consultants, Ahmedabad in order to provide updated and permanent education in mutually-agreed domains.
- 1.2 The cost of expenses incurred in performing any activity pursuant to this Memorandum of Understanding such as commencement and materialization of the project, training, advisory of visits and staff attachments will be negotiated to the mutual acceptance of both parties.

## **DURATION AND TERMINATION**

- 2.1 This Memorandum shall commence on the date of execution of the same and shall remain in force for duration for five years and shall continue to remain in force by after review and mutual agreement between the parties.
- 2.2 Each party may terminate the Memorandum by providing three months' notice in advance to the other party. Upon termination, each party accordingly shall return any documents retained by the same to its original owner.

# **RELATIONSHIP BETWEENT THE PARTIES**

- 3.1 Nothing contained herein shall be construed so as to constitute a joint venture partnership or formal business organization or any kind between the parties to constitute either party as the agent of the other.
- 3.2 Sid Consultants, Ahmedabad and L. D. College of Engineering, Ahmedabad hereby agree that this cooperation shall be identified as the parent document of any programmes executed between the parties.

**3.3 Further agreement concerning any programmes** shall be entered into prior to the commencement of the activities or programmes. Such agreement shall not become effective until they have been reduced into writing, approved and executed by the duly authorized representative of the parties.

### CONFIDENTIALITY

**4.1 All information and/or data** may be exchanged, acquired and shared in connection with the area of cooperation between **Sid Consultants**, **Ahmedabad** and **L. D. College of Engineering**, **Ahmedabad** pursuant to this Memorandum of Understanding shall be treated strictly confidential and shall not under any circumstances be divulged by the receiving party to any third party without the prior written consent of the originating party unless otherwise same has already been in public domain.

#### **GENERAL**

**5.1** The provisions of this Memorandum may be amended at any time by the mutual consent in writing of both parties.

**5.2 Save for Clause 4.1,** the parties agree that this Memorandum represent the mutual understanding of the parties and is not intended nor shall be deemed to be a binding contract and shall not give rise to any rights and liabilities under a contract.
